# A RESOLUTION APPROVING A DEDICATION OF PUBLIC RIGHT OF WAY FROM COBURG NORTH CONDOMINIUM AND AUTHORIZING THE CITY ADMINISTRATOR TO COMPLETE THE DEDICATION ON BEHALF OF THE CITY

**WHEREAS**, the Coburg City Council have adopted a System Development Charge (SDC) Ordinance and Resolution allowing for SDC credits; and

**WHEREAS**, Coburg North Condominium (grantor) prepared a dedication of public Right of Way (Exhibit A);

- 1. The City Council accepts the land donated as Right of Way.
- **2.** The City Council authorizes the City Administrator to sign acceptance of the Right of Way donation.

#### DEDICATION OF PUBLIC RIGHT OF WAY

THE ASSOCIATION OF UNIT OWNERS OF COBURG NORTH CONDOMINIUM, GRANTOR, grants a public right of way to the CITY OF COBURG, an OREGON MUNICIPAL CORPORATION, GRANTEE, the following described real property, free of encumbrances except as specifically set forth herein, for public purposes, including streets and utilities:

No. 2014-024948 Lane County Oregon Deeds and Records, said point being on the west margin of North Coburg Industrial Way, 40.0 feet westerly of, when measured at right angles to the centerline of North Coburg Industrial Way; thence leaving said westerly margin and running along the south boundary of said Tract A North 89°50'25" West 15.22 feet to a point; thence leaving said south boundary and running parallel to the west margin of North Coburg Industrial Way North 9°35'27" West 717.04 feet to a point on the north boundary of said Tract A; thence along the north boundary of said Tract A South 89°50' 26" East 15.22 feet to the northeast corner of said Tract A, said point being on the west margin of North Coburg Industrial Way, 40.0 feet westerly of, when measured at right angles to, the centerline of North Coburg Industrial Way; thence along the west margin of North Coburg Industrial Way South 9°35'27 East 717.04 feet to the point of beginning, all in Lane County Oregon.


