A RESOLUTION ACCEPTING THE NOVEMBER 5, 2019 SPECIAL ELECTION, **CERTIFIED RESULTS ON MEASURE 20-303 FROM LANE COUNTY**

WHEREAS, Council adopted Resolution 2019-18 on July 9, 2019 setting a ballot title and directing the City Recorder to get it on ballot for the November 5, 2019 Special Election.

WHEREAS, Ballot title was noticed as required and no petitions were received.

WHEREAS, City filed the notice of measure with Lane County Elections and received measure number 20-303 that states:

Caption: Change Motor Fuel Tax to six cents (.06).

Question: Shall Coburg's Motor Fuel Tax be changed by increasing it to six cents a gallon?

Summary: Coburg's current motor fuel tax is three cents a gallon. An affirmative answer to this referral will approve the Coburg City Council's adoption of an amended motor vehicle fuel tax of six cents a gallon. Any funds raised by the Motor Vehicle Fuel Tax may only be spent for activities and/or materials directly related to the repairs or improvements to Coburg's streets and/or the retirement of bonds purchased for the purpose of activities and/or materials for repairs or improvements to Coburg's streets.

WHEREAS, City of Coburg received the certified results dated November 20, 2019, from the Lane County Clerk as required by state law. The results are as follows;
