

## RESOLUTION 2016-17

### A RESOLUTION ADOPTING CHANGES TO THE BUILDING, OTHER PERMIT, AND INSPECTION FEES

**WHEREAS**, Ordinance A-136 as amended by Ordinance A-136-L establishes building, other permit, and inspection fees; and

**WHEREAS**, Ordinance A-136-L requires that, future changes in the City of Coburg's building, other permit, and inspection fees shall be adopted by resolution; and

**WHEREAS**, as required by OAR 918-020-0220, the City of Coburg is providing notice of fee changes;

#### **NOW THEREFORE, THE COBURG CITY COUNCIL RESOLVES AS FOLLOWS:**


1. The City of Coburg adopts adjustments and changes to the building, other permit, and inspection fees which is directed by the aforementioned Ordinance A-136-L.
2. The adjustments and changes are in compliance with noticing requirements of aforementioned OAR 918-020-0220.

## City of Coburg – Building, other permit and Inspection Fee Schedule

<i>* Includes the concrete slab, runners or foundations that are prescriptive, electrical feeder and plumbing connections and all cross-over connections. Decks, other accessory structures, and foundations that are not prescriptive, utility connections beyond 30 lineal feet, new electrical services or additional branch circuits, and new plumbing - may require separate permits. All decks 30" above ground, carports, garages, porches, and patios are based on valuation and may also require separate permits.</i>	

### C. Manufactured Dwelling/RV Parks – Area Development Permit (ADP)

The Area Development Permit fee to be calculated based on the valuations shown in Table 2 of OAR 918-600-0030 for Manufactured Dwelling/Mobile Home Parks and Table 2 of OAR 918-650-0030 for Recreational Park & Organizational Camp – and applying the valuation amount to the City of Coburg Structural Permit Fee table included in this schedule.
